## Statement of Understanding

Please read each statement carefully. By agreeing to these conditions for admission, you understand fully the Langston University academic, administrative, and immigration regulatory policies to become a LU student on F-1 visa.

- 1. I understand that I am applying for the Langston University campus located in rural Langston, Oklahoma. This campus is approximately 30- 45 minutes from the nearest city. \_\_\_\_\_(initial here)**
- 2. I understand that as a freshmen student under 25 years of age and having less than 60 credit hours with Langston University, I am required to live in on campus housing. \_\_\_\_\_(initial here)**
- 3. I understand that I must submit all application forms and supporting documents to the LU Admissions Office (International Admissions) by the deadline date listed. If my application failed to meet the deadline, it will be considered for the next earliest semester.**
4. I understand that all information given on the application forms must be accurate. Failure to list all colleges previously attended, or falsification of application information or any of my academic records will result in my suspension for academic misconduct and immediate dismissal from LU.
5. I understand that I must submit official academic credentials from all schools I am currently attending and/or have attended in the past. I understand that I must meet the grade point average for the program I intend to pursue.
6. I understand that if English is not the primary vernacular in my country, I must meet the English proficiency outlined before the admission will be granted. However, I may submit the application for admission to LU without having met the English requirement but only for evaluation of my academic credentials. If I have met all the admission requirements except for the English proficiency and wish to attend an intensive English program, I must apply to the English language school approved by the State Board of Regents to receive the I-20 and the provisional acceptance letter from LU.
- 7. I understand that if I enter the U.S. on I-20 issued by LU, I must enroll and complete 12 credit 12 credit hours before I am eligible to transfer to another institution in the U.S. \_\_\_\_\_(initial here)**
8. I understand that I must be prepared to bring with me to LU sufficient funds (a minimum of \$22,005) to cover tuition, fees, textbooks and supplies, and living expenses for one sixteen-week semester. I further understand that additional funds must be at my disposal for my subsequent semesters study at LU.
- 9. I understand it is very important to maintain my visa status by making good academic progress at all times during my stay in the U.S. I am required to enroll and complete successfully a minimum of 12 credit hours as an undergraduate student during Spring and Fall semesters. I further understand that while I am at LU, I must comply with the university Code of Student Conduct.**

10. I understand that I must be in proper status with the U.S. Immigration and Customs Enforcement (ICE) while I am in the U.S. If reinstatement of F-1 visa status or change in visa classification is required, I must consult the LU International admissions counselor and file appropriate application with the ICE. I will not be permitted to enroll until I have completed all the paper work for reinstatement of student status with the LU International counselor. If I am changing from any of other non-immigrant visa status to student visa status, I will not be permitted to enroll until the ICE notification of approval is received.
11. **I understand that I must maintain a valid passport at all times by applying for the renewal at least 6 months prior to its expiration.**
12. I understand that my I-20 must be valid throughout the duration of my study. The extension must be requested at least 30 days prior to its expiration at the International Admissions Office.
13. **I understand that I must always provide the current address information to LU by informing the International Admissions Counselor when there is any change either in my residence in the U.S. or in my family address in my home country.**
14. I understand that my F-1 visa status will prohibit my engaging in off-campus employment without prior authorization from the International Counselor. If I am found to be working off-campus without a proper authorization, I will lose my visa status and may face immediate deportation.
15. I understand that I must submit the proof of required immunization before enrollment.
16. **I understand that I am required to complete a tuberculosis skin test during my first semester at LU Student Health Center (University of Women) before I am permitted to enroll for subsequent semesters. I understand that if X-Ray is required as the result of testing, I must visit an off-campus facility at an appointed date and time to meet the testing requirement for enrollment.**
